CREEDE CEMETERY AMETHYST ADDITION

KNOW ALL MEN BY THESE PRESENTS THAT the Creede Cemetery, Amethyst Addition (the "Cemetery" herein) is owned by and under the jurisdiction of Mineral County, Colorado (the "County" herein), governed by its Board of County Commissioners (the "Board" herein) and the undersigned duly authorized representative of the Board (the "Representative" herein).

In consideration of _____ Dollars (\$ _____) paid to the County by _____, the original purchaser herein, whether one or more (the "Purchaser" herein), whose address is _____ the receipt of which is hereby acknowledged, the Representative does hereby grant, bargain, sell and convey to the Purchaser, the spouse of the Purchaser and the lineal descendants of the Purchaser (collectively, the "Grantees") and no one else, the following Plots in the Cemetery in Row No. _____, Block No. _____: Plot(s) No. _____

TO HAVE AND TO HOLD the said Plot(s) unto the said Purchaser and the Grantees subject to:

1. All provisions contained in the Rules and Regulations relating to the Cemetery which now are or may be hereafter established or amended by the Board. Such Rules and Regulations are on file in the offices of the Board. Unless changed by the Board, the surface of the cemetery is open to the public.
2. If the Purchaser or Grantee of any Plot(s) that has not been used for burial elects to sell the same, such Plot(s) must be sold to the County and for the same price paid for that Plot(s) by the Purchaser. However, upon the written request of the immediate family of a decedent who is not a lineal descendant of the Purchaser or of Grantee(s), delivered to the Representative, and upon the delivery to the Representative of the written approval of interment signed by the Purchaser or the then applicable Grantee(s), both of which writings being notarized, the Representative shall permit the interment of that non-lineal descendant in a Plot of the original Purchaser; Provided however that no transfer of legal ownership of that Plot shall occur.
3. No initial transfer to the Purchaser or subsequent transfer to any Grantee or subsequent resale to the County shall take effect until a copy of this Deed and a synopsis of any other necessary details have been entered in one or more ledgers kept for that purpose, together with a Representative's certificate of transfer noted in the ledger(s).
4. No Plot shall be used for any purpose whatsoever except for the interment of the dead.
5. A Purchaser and any Grantee(s) shall have the right to erect stones or similar monuments subject to the written approval of the Representative.
